A workshop was held on August 14, 2017 to exchange opinions for the sustainability of the SHKBs established as part of Ministry of Family and Social Policies in order to deliver comprehensive and accessible services with the purpose to support the social inclusion of disadvantageous people and their families.

Training programs of the foreign healthcare staff who are receiving training as observers in the affiliated training and research hospitals of the Ministry are ongoing under bilateral agreements. Within the framework of such programs, a total of 199 foreign healthcare staff received training as of 31 August 2017 as follows:

Out of 8 foreign healthcare staff:

 Training of 1 Palestinian healthcare staff is ongoing in the field of Pediatrics for 5 September 2016- 1 September 2017,

- Training of 1 Kosovan healthcare staff is ongoing in the field of Cardiovascular Surgery for 12 June- 10 December 2017,
- Training of 2 Uzbek healthcare staff is ongoing in the field of Hematology for 31 July -15 September 2017,
- Training of 2 Uzbek healthcare staff is ongoing in the field of Pathology for 31 July - 31 October 2017,
- Training of 2 Uzbek healthcare staff is ongoing in the field of Genetics for 31 July - 15 September 2017,

at the Research and Training Hospitals.

Treatment of Foreign Patients in Turkey

As per "Article 14 of the Basic Law on Health Services no 3359" 142 patients and as per Bilateral Agreements and Protocols 522 patients - 664 foreign patients in total - were treated in Turkey as of Thursday, August 31, 2017.
