Guinea-Bissau and Senegal Health Week Preparation Program

Regarding this request, a study visit was conducted to Gine Bissau before the health week, to investigate the infrastructure, physical suitability of health centers and deficiencies of hardware.

Within the scope of this programme, a delegation from the General Directorate of EU and Foreign Affairs of the Ministry of Health visited **Gine Bissau** on **9 to 13 March. 2014** and met with Prime Minister of Guinea-Bissau, the Minister of Health, Bisav Mayor and our Bissau Ambassador. The delegation later moved to **Senegal**, on **13-14 March, 2014** and met with the Prime Minister of Senegal and our Dakhar Ambassador. During the visits discussions were held on the subject.

Training of Foreign Healthcare Personnel in Turkey



As of March 31'st, 2014, training of 71 foreign health personnel has been completed, where the training of 48 foreign health personnel is going on. Training of 43 foreign health personnel has being planned, thus a total of 161 foreign health personnel (111 physicians, 50 allied health personnel) will be trained in our country.
